
The NOC is issued subject to the execution of agreement with Government in the prescribed format.

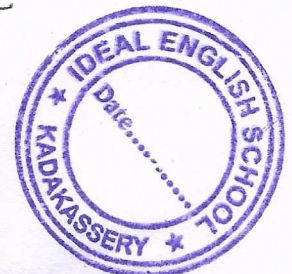

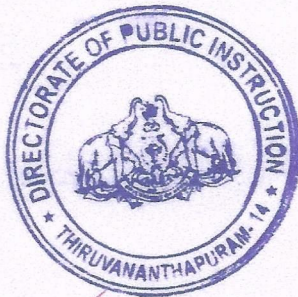


